RE: Further Recall Instructions

Good morning,

You are receiving this follow-up notice because the South Dakota Medical Cannabis Program (SDMCP) has requested a voluntary product recall of medical cannabis products from 605 Cannabis doing business as Badlands. We have alleged that a failure to test product, mislabeling, contamination, the lack of inventory tracking, and the failure to have licenses for edible products pose a risk to health and safety of the products sold by Badlands.

It has been brought to our attention your establishment may have purchased some of the recalled product.

Badlands is cooperating with the recall request; however, it is important for dispensaries to understand the next steps for handling of recalled products.

To comply with the recall, all affected establishments shall immediately store the affected cannabis in storage containers labeled prominently with the words **RECALLED – DO NOT TRANSFER** as outlined in [ARSD 44:90:12:02](#). Please place the product in a secure locked location and wait for further instruction from the SDMCP as to what to do with the recalled product. Sales of recalled product is not allowed.

In addition, in order to meet the notification requirement to your patients of the recalled products, you are allowed to post the enclosed recall letter dated February 10, 2023, as “public notice” in areas in the dispensary such as on the front door, on a bulletin board, or near the cash registers.

SUBJECT: RECALL OF MEDICAL CANNABIS PRODUCT FROM 605 CANNABIS D/B/A BADLANDS

The South Dakota Medical Cannabis Program (SDMCP) has requested a voluntary product recall because of allegations of the risk to health and safety for products from 605 Cannabis doing business as Badlands.

Badlands is cooperating with the recall request. However, it is important for dispensaries to understand the reasons for the request.

We have alleged that a failure to test product, mislabeling, contamination, the lack of inventory tracking and the failure to have licenses for edible products pose a risk to health and safety of the products sold by Badlands.

Dispensary establishments shall contact and inform all medical cannabis patients that may have purchased any of the above product notifying them of the recall. Dispensaries may contact the Department with specific patient information and the Department will send an individual notice of recall.

Patients who have this affected medical cannabis in their possession should destroy it or return it to the dispensary from which it was purchased for proper disposal. Patients who experience adverse health effects from consuming any recalled medical cannabis should seek medical attention immediately.

We have attached a list of the products that are necessary for recall.
